Did You Know?

Too large a fuse isn't any better than no fuse.

POSSIBLE CURE FOR MOTION SICKNESS

Take 2 to 4 capsules of powdered ginger root 20 to 25 minutes before qoing into rough water. If you still feel queasy take more capsules. There is an almost automatic dosage indicator in the form of the "ginger burp." A burn after the last capsule indicates that enough has been taken. The burp will cause a slight burning sensation in the upper gastro-intestinal tract. If you haven't burped after the first few capsules wait about 5 minutes and then take 4 more capsules. A common intake is 3 or 4 capsules per hour or 12 capsules every 3 or 4 hours for the duration of the trip. Give the ginger a chance to go to work as the ginger has a nasty taste that makes being sick even more unpleasant.

Use only capsules to take ginger root as it is slightly caustic and irritating. The material can be obtained from health food shops. It does not have the side effect of causing drowsiness or other disorders of the central nervous system.

Warning: Check with the family physician before taking large doses, especially if you take other medication. This is a condensation of "Ginger: New Cure for Mal de Mer?" in the August 1982 issue of "Motor Boating & Sailing."

Here is more on seasickness remedies copied from the Feb. 1982 issue of "Motor Boating & Sailing" --

RX RATED: TRANSDERM-V

I am writing to caution fellow yachtsmen against careless and perhaps inadvisable use of the well-publicized new seasickness remedy, Transderm-V, featured in the November issue. The drug in the discs, scopolamine, which is not new, has largely been dropped as a preoperative medication because of the intensity and unpredictability of its side effects. My family used Transderm-V on a cruise last summer. My daughter and son got seasick despite the medication, and my wife and daughter developed severe blurring of vision and dizziness after wearing the discs for 48 hours and for two full days after their removal.

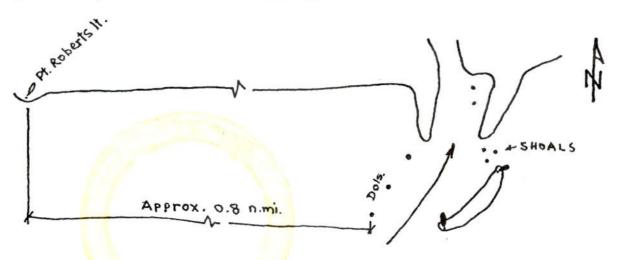
Among the reported side effects of scopolamine are: blurred vision, difficulty with urination, tachycardia (rapid heartbeat), palpitations, increased pressure in the eye, headache, nervousness, drowsiness, weakness, dizziness and insomnia. The elderly may react to even small doses of the drug. I would recommend that it be used only by healthy young adults to age 40 or 45, only after checking with their doctor, and for not more than 24-48 hours. It should be avoided, in my opinion, by children, the elderly, pregnant women, and anyone with glaucoma, difficulty with urination, or an unstable heart condition.

The following information may prove helpful to anyone contemplating visiting the Point Roberts Marina by boat. The marina entrance can be difficult to spot in poor weather or at night.

Newer editions of Canadian chart 3450 show the general location of the marina with a red "M" with a circle around it. American chart 18421 actually shows the marina basin. Neither chart has any detail of the breakwater or dolphins marking the safe entrance channel. The sketch below shows the general layout of the marina entrance.



If you do not have American chart 18421 you should first locate the marina entrance on chart 3450 at approximately 48° - 58.5°N latitude and 123° - 03.7 W longitude. This corresponds to a distance of about 0.8 nautical miles from the prominent Point Roberts light and is shown by the tip of the arrowhead on the sketch above. The marina is entered between the rock breakwater and the row of dolphins as shown. There is a privately maintained quick flashing red light mounted on a small triangular frame at the southwestern end of the breakwater. The northeastern end is marked by a similarily mounted quick flashing white light.

At present the dolphins on the westerly side of the channel are unmarked, however, Harbourmaster Jim Lawson has told me that the marina will be installing flourescent day markers on these dolphins. This should be done by the end of this year.

I hope this brief description will help alleviate the uncertainty resulting from the lack of detail on the present nautical charts.
